

Terms of Use

A. General

1. These Terms of Use (“**Terms of Use**”) regulate your use of the Services (as defined below) operated by Arrowmedia Israel LTD or Cybertech Singapore (CYSING) Pte. LTD or Cybertech USA, by using various platforms provided by different providers (the “**Platform**”).
2. Using or receiving the Services is subject to your compliance and acceptance of these Terms of Use and the terms of the Platform as published here. Please be sure to examine the Terms of Use of the Host and the Platform before making any use of the Services.
3. By registering to the Services or receiving the Services you fully agree and give your consent to these Terms of Use.
4. The Host has the right to change and update these Terms of Use. The updated Terms of Use may be viewed at the registration page for the Services and such updated Terms of Use will be binding effective immediately from the moment they were uploaded to the registration page.

B. The Services

5. The Host will offer lecturers, courses, lessons, presentations and any other type of information sharing from various companies and individuals in different fields, all within the spectrum of an online conference to be organized by the Host (the “**DLD Conference**”), and by the use of the Platform (the “**Services**”).
 6. The registration for the Services is subject to completing the registration process in the registration page
 7. You are aware and agree that some of the Services might be subject to a payment of a registration fee, and in that case, receiving the Services is subject to a full payment of the registration fee as detailed in the registration page.
 8. The dates and times of the Services may be changed or updated after the registration. The Host undertakes to update about such changes.
 9. Due to the fact that the Services are provided in collaboration with various companies and individuals and by the Platform, in the event that the Host is unable to provide the Services because of any reason beyond its control, it has the right to cancel or postpone the Services upon its sole discretion.
10. Termination

You are entitled to cancel your registration to the Services and receive a refund according to the following terms:

- 10.1. Up to and including 7 days before the event date - A full refund of the registration fees.
- 10.2. Less than 7 days before the event date – no refund.

C. Property and Intellectual Property

11. All the content from any kind, (including text, graphics, designs, software, code, audio, drawings, plans, photographs and other pictures, videos, tones, trademarks and trade symbols, graphs, tables, methods and techniques) from any kind which will be provided or published in the Services is the intellectual property of the Host, or any third parties and you agree and aware that by receiving the Services you do not have any right in such intellectual property (“**Intellectual Property**”).
12. You agree and aware that you will not use, copy, record, distribute, display, transfer, amend, process, create, sell or lease any part of the Intellectual Property, whether on your own or through or by a cooperation or with any third party, in any way or using any means, whether electronic, mechanical, optical, through photographic or recording means, or any other means, without obtaining the prior written consent of the Host or other rights holders, as applicable, and subject to the terms of such consent (if any).

D. Liability

13. Some of the content of the Services is provided by third parties. The Host will not be responsible to any content provided by third parties.
14. The Host will not be liable, directly or indirectly, to damages (direct or indirect), claims, law suits, loss arising from the use of such content by you.

15. You fully represent and warrant that the use, of any kind, of the content published in the Services is upon your own responsibility.
16. Without derogating from the provisions of this Terms of Use, the Host is exempted from liability for any damages, losses or expenses you may incur, directly or indirectly, as a result of one of the following events/factors:
 - 16.1. Failure to provide the Services due to reasons related to the Platform;
 - 16.2. Failure to provide the Services due to reasons related to third parties who have undertaken to provide content to the Host for the Services.

E. Privacy

17. In order to receive the Services from the Host, you may be required to input Personal Data about you. "Personal Data" means all the information you have provided in the registration form, including your full name, the name of the company or organization, your position, address, telephone number, email address or any other information you wish to include in the registration form (such as a photo, Curriculum Vitae, social-media links, etc.). By registering to the Services, you warrant that you are aware that you are not under any legal obligation to provide the information that you have provided, and that you provide this information with your full consent and of your own free will.
18. Transfer to third parties. The information provided by you shall not delivered to any third party, except for in the following cases:
 - 18.1. You are aware that some of the Services are provided in collaboration with various third-party companies and individuals, including the Platform providers, and in such case:
 - 18.1.1. By registering or participating in such Services you give the Host your approval to transfer your Personal Data to those specific third parties which participate or sponsor the DLD Conference, including the DLD Conference chairmen.
 - 18.1.2. Furthermore, by participating in a live chat with such third-parties' representatives, and by actively choosing to view such representatives' Personal Data, you give the Host your approval to transfer your Personal Data to such third-parties which have also actively chose to view others Personal Data ("Online Networking"). The use of Online Networking may be subject to payment by the participant, depending on the specific event in which it is offered.
 - 18.1.3. By leaving a message request to a specific third-party to contact you, you give the Host your approval to transfer your Personal Data to such third-party.

You are hereby made aware and grant your consent that the aforementioned third parties', to which Personal Data may be transferred to as specified under this Section, may be located outside the territories of the state of Israel, including within the territories of the United States.
 - 18.2. For the registration process to the services of the Platform allow you to receive the Services. By registering to the Service, you give your permission to the Host to provide your details to the Platform for the purposes mentioned above.
 - 18.3. If you gave your permission.
 - 18.4. If it is required to do so by judicial order or by law;
 - 18.5. If the Host receives a warning that legal action has been instituted against it for actions performed by you, or in the event of a claim, lawsuit, demand or legal proceedings, if existing, between you and the Host;
 - 18.6. If the Host organizes its activities within the framework of another body, including a merger with another entity or a merger of activity. In such a case, the Host shall ensure that the third party into which the Host is merged shall accept upon itself the provisions of this Privacy Policy;
 - 18.7. If a claim is raised or a suspicion arises at the Host, that you committed an act or omission that harms or may harm the Host, anyone acting on its behalf or any third parties;

- 18.8. If a claim is raised or a suspicion arises at the Host that you made or used the Services for the purpose of carrying out an illegal act or to encourage the performance of such an act;
- 18.9. If a claim is raised or a suspicion arises at the Host, that you violated any of the terms of these Terms of Use, or any agreement with the Host or with anyone on its behalf;
19. By registering to the Services, you give your consent that the information you provided to the Host, be held in one or more databases of the Host or anyone acting on its behalf, to the extent that this is required by law, and that such information shall be used in accordance with the following purposes:
 - 19.1. Marketing, advertising, sales promotion and sales, and for the purposes, including by way of direct mail, through any media channel that it deems fit;
 - 19.2. Conducting surveys and any other online use in connection with a marketing issue;
 - 19.3. For internal needs, such as the need to investigate complaints;
 - 19.4. For mailing marketing and advertisement materials;
20. Subject to your express consent, the Host may use the Personal Data for marketing purposes, including: to send you marketing/advertisement materials through any lawfully permitted means of communication, including by direct mail, e-mail, SMS messages, *inter alia*, based on data segmentation or your preferences, and those of other users, as recorded during the use of the Services.
21. By registering to the Services, you approve and give your full consent to the terms of use and privacy policy of the Platform, for all applicable matters.
22. It should be clarified that after transferring your Personal Data to a third-party, the Host will not be liable or responsible and it is not a party to any engagement or privacy policy, between you and any third party, and such engagement or contact is subject to your sole discretion.

F. Notices and Notifications

23. Various notices and notifications from the Host, including advertisement mail, may be sent to you by e-mail, by direct post, through SMS messages or through any other means of communication, to the address provided by you in the registration form for the Services, in the event that you approved receiving such notices and notifications.

G. Jurisdiction

24. Use of the Services is subject solely to Israeli law. Unique jurisdiction over all disputes relating to the Services is exclusively awarded to the competent courts of Tel Aviv-Jaffa.
